SCHOOL FEES - TERMS & CONDITIONS OF PAYMENT

These payment terms and conditions for the academic year 2016-2017 cancel and replace all previous versions.

ENROLMENT CONFIRMATION FEE

Receipt by the school of the application form does not constitute a guarantee of placement. Parents will be informed in writing of the school's decision following consideration of the submitted documents (including previous school reports), as well as personal interview, if possible.

The Enrolment Confirmation Fee for new students becomes payable immediately upon acceptance of a place offered. This payment secures the place. The amount is non-refundable, and is not credited towards the school fees.

TUITION FEE REDUCTIONS

- (i) There is a 10% reduction for the second child and subsequent children from the same family enrolled concurrently in the school.
- (ii) There is a 2.0% reduction for settlement of the tuition fees for the whole school year if received as one single payment by 15 August at the latest.

These reductions do not apply to families whose school fees are supported by a company, whether directly or indirectly, wholly or partially.

PAYMENT

Payment of tuition fees must be made according to one of the following options (except for families whose school fees are supported by a company):

- Monthly, in advance, on the last day of the month, with first payment due on or before 31 August. In case of repeated delay in payment by monthly installments, the school reserves the right to apply the advance termly payment, without cancellation of the surcharge.
- Termly (on or before 15.08, 15.12, 15.03) or
- Annually (on or before 15.08)

Reminders sent with regard to balances past their due date are subject to a CHF 25.- charge for the second reminder, then CHF 100.- for any additional reminder. Any other cost of debt recovery will be charged to the parents.

Other additional costs will be billed separately for immediate settlement.

All payments due for the current academic year must be cleared in their entirety before the start of each new school year, otherwise the school reserves the right to refuse a student for the following academic year.

In case of enrolment during the course of the school year, the tuition fees for the term which has already begun are due in full, irrespective of the exact starting date.

WITHDRAWAL

The school **must be notified in writing** of a student's departure before the following dates, even if the decision is not yet definitive:

- a) 15 September for the end of the first academic term
- b) 15 December for the end of the second academic term
- c) 31 March for the end of the school year

In all cases, the tuition fees for a term which has been started, or for which an invoice has already been issued, are due in full.

In the absence of formal written notification of withdrawal for the end of the current academic year, the enrolment of a student is tacitly carried forward from year to year.

[In the event that a serious infringement of the school's regulations results in a student being asked to leave Haut-Lac, the obligation to pay the fees for the current term **in full** remains.]

Any legal dispute arising from or relating to these terms and conditions, and a student's enrolment and schooling at Haut-Lac International Bilingual School, is exclusively subject to Swiss law and the ruling of the appropriate courts having jurisdiction for the region of Vevey.

The parents undertake to inform the school immediately of any changes in their family's or the child's circumstances.
